



COVID-19 COMMUNITY STRATEGIC REENTRY PLAN

SAINT PAUL ISLAND, ALASKA

The following plan is based on a four-phased approach with guidance from federal and state health and other experts. This plan and the phases will provide guidance to the Saint Paul Island Unified Command Team when lifting State or local government issued mandates and restrictions that were implemented to protect the health of the community so that Saint Paul Island residents can begin to get back to normal daily living all while continuing to protect our community members.

ACTIONS TAKEN TO DATE

- Declaration of emergency by City and Tribal Governments
- Incident command structures in place for governments, businesses, entities, health provider
- Formation of Saint Paul Island Unified Command
- Development and implementation of COVID-19 polices for various entities
- City Council non-essential travel ban
- City Council Emergency Ordinance closing Saint Paul Harbor
- Development of Saint Paul Island COVID-19 Quarantine Plan
- Development of local Guide to Social Distancing and Hunkering Down
- Development of Notice to Mariners
- Purchase of PPE for first responders, health care staff, janitorial staff, etc.
- Lab and rapid tests for COVID-19 available at Saint Paul Health Center
- Numerous local media campaigns through social media, KUHB radio, flyers, NIXLE

COVID-19 CASE STATUS

- 0 Cases
- 0 Hospitalizations
- 0 Deaths
- 58 Tests Performed as of 9/25/20

OTHER UNIQUE FACTORS

- Limited passenger air service
- Limited vessel traffic and requirement that crews stay onboard when in harbor
- Protective measures in place for when personnel are receiving cargo
- All persons traveling inbound on charter flights self-quarantined for 14 days

PHASED APPROACH

- Based on up-to-date data and readiness
- Mitigates risk of transmission and resurgence
- Protects the most vulnerable

LEVELS OF RISK



HIGH – STOP!

We are seeing a consistent or rapid increase in cases or if we think we are running out of capacity to care for people with COVID-19 (regardless of the trend in cases), we will need to reimplement protective measures and restrictions



MEDIUM – PROCEED WITH EXTREME CAUTION

If the situation is becoming unstable or we are seeing cases or increase in cases, we will implement protective measures and restrictions



MODERATE – PROCEED WITH CAUTION

If the situation is stable or we are seeing our first case or slow increase in cases, we will implement protective measures and restrictions



LOW – GO

We are seeing no cases or downward trends in cases and all is going well, we will methodically move to lift protective measures and restrictions

GREEN = Level/Phase 4 **YELLOW** = Level/Phase 3 **ORANGE** = Level/Phase 2 **RED** = Level/Phase 1

GUIDELINES FOR INDIVIDUALS AT ALL PHASES

Continue to adhere to CDC, State and local guidance, particularly with respect to face coverings

Continue to Practice Good Hygiene

- ✓ Wash your hands with soap and water
- ✓ Avoid touching your face
- ✓ Sneeze or cough into a tissue, or the inside of your elbow
- ✓ Disinfect frequently used items and surfaces as much as possible
- ✓ Wear face coverings while in public

People Who Feel Sick Should Stay Home

- ✓ Do not go to work or store
- ✓ Contact and follow advice of medical provider

GUIDELINES FOR EMPLOYERS AT ALL PHASES

Develop and implement appropriate policies, in accordance with Federal, State and local regulations and guidance, and informed by industry best practices, regarding:

PHYSICAL DISTANCING GUIDELINES

- Physical distancing is a set of actions taken to stop or slow the spread of a highly contagious disease, in this case COVID-19
- The goal of physical distancing is to limit face-to-face contact to decrease the spread of illness among people in community settings
- Current recommendation is to keep at least six (6) feet away from other people when going out in public
- During Level/Phase 2 of reentry, 20 people are allowed to be in a group as long as they are physical distancing
- During Level/Phase 3 of reentry, 50 people are allowed to be in a group as long as they are physical distancing
- Some businesses, public and private organizations and government institutions facilities may not allow for the maximum number of people allowed in a space during Levels/Phases 2 and 3, therefore they should measure the space and calculate the maximum number for people allowed in the space and post a notice for customers or visiting public

- If a large enough change in one category is observed this may trigger to move to a different level.
- A combination to changes in more than one category may trigger to move to a different level.
