Only persons 21 years of age or older can submit a bid. Sales of the firearms will be completed by ZArmory, who will conduct the required background checks and completion of required paperwork. Failure to pass a background check will result in the next highest bid to be chosen. Background check, paperwork, and completion of the of the sale of ammunition and firearms will be done at ZArmory located at 115 Gorbatch Street, Saint Paul Island, Alaska.

Instructions to Bidders

1. If you would like to look at the ammunition, firearms, or sites please contact Phillip Zavadil, City Manager, a day in advance to arrange a time to look at the items.

- 2. Bid document must contain:
 - a. Bidder's Name
 - b. Specific Item Bidding On:
 - Make, Specifications, and Quantity for Ammunition
 - Make, Model and Serial Number of Firearms
 - Number of Firearm Sites
 - c. Amount of Bid for Each Item
- 3. At time of the opening of the bids, their contents will be made public.
- 4. Bids may be mailed to the City or submitted in person to Aubrey Wegeleben, City Clerk.
- 5. The City of Saint Paul makes no warranty to the condition of the ammunition, firearms, firearm sites.
- 6. Bids will be opened at 3:00 pm Friday, April 19, 2024, in the City Council Chambers. All bids must be submitted before the opening time.
- 7. Multiple bids by the same bidder may be submitted. The highest bid submitted by the bidder will be the final offer made.
- 8. If payment cannot be made in full at that time of award, the next highest bid shall be chosen.

- 10. Envelopes with bids should not have the bidder's name on the outside of the envelope.
